Title of Research Study: Pediatric Integrative Medicine Research Agenda Survey

Background: According to the 2007 NHIS Child Complementary and Alternative Medicine (CAM) Survey, CAM use is common among pediatric patients and one fifth of children with chronic health problems use some type of CAM. CAM is generally described as those therapies and practices that exist outside of the conventional medical system for which there is some high-quality evidence of safety and effectiveness. Integrative medicine combines treatments from conventional medicine and CAM. In an effort to advance pediatric CAM as a field, researchers in pediatric CAM proposed a research agenda in 1999. This agenda was updated in 2010. The present study is to expand on this research agenda integrating input and set forth an integrated research agenda across clinical, health services and policy research areas.

Purpose: You are being asked to participate in a research study that will develop a plan for future research activities in the field of pediatric CAM/IM, including clinical, health services, and policy research. You are being asked to participate as we would like to involve as many people as possible from various backgrounds that are interested in pediatric CAM/IM.
